#### 0. Introduction

The Government of Kazakhstan ("the GoK") approached the European Bank for Reconstruction and Development ("EBRD" or "the Bank") to provide a sovereign guaranteed loan to KazAvtoZhol NC JSC¹ ("the Company") to finance the urgent reconstruction of the 220 km section of Kyzylorda-Zhezkazgan Road and greenfield construction of the 14.6 km Kyzylorda Bypass (four lanes).

The reconstruction of 220 km of the 427 km road is categorised as "B" in accordance with the EBRD Environmental and Social (E&S) Policy (2019) and an E&S Due Diligence has been undertaken for that section. The reconstructed road will follow the alignment of the existing road: a two-lane, category III road constructed about 30 years ago.

The construction of the 14.6 km Kyzylorda Bypass ("the Project") is a greenfield development that could result in potentially significant adverse future environmental and/or social impacts and the EBRD has categorised this Project as "A" in terms of its 2019 E&S Policy, which means that a comprehensive E&S Impact Assessment ("ESIA") and associated documents must be prepared, followed by their public disclosure for a minimum period of 120 days.

The Project beneficiary - the Company, was designated by the GoK as the National Operator for the management of highways<sup>2</sup>. The National Operator, in accordance with the Law of the Republic of Kazakhstan (RoK) On Highways, is empowered to organise paid traffic and develop roadside services<sup>3</sup>. Kyzylorda Regional Branch of KazAvtoZhol NC JSC acts as the Project Implementing Agency ("PIU"), responsible for managing the day-to-day preparation and implementation of the Project.

The Bank has engaged ATMS Solutions Ltd. (Armenia) ("the Consultant") to carry out an Environmental and Social Assessment of the Project ("the Assignment"). Within the Assignment the Consultant prepared the given document - Stakeholder Engagement Plan ("SEP").

The PIU will be responsible for monitoring of implementation of the SEP-related activities in accordance with this SEP and EBRD Performance Requirements (PRs).

The SEP's objectives are to:

- present the national legal framework and the EBRD's requirements pertaining to stakeholder engagement process;
- identify all Project stakeholders, including those who might be considered vulnerable and might need more support during the consultation process;
- develop a stakeholder engagement programme that will be implemented by the Project to ensure that the E&S information on the Project is timely provided and properly communicated to the Project's stakeholders, and the feedback communication channels are available to the them;
- define the means of engaging with the identified stakeholders in a meaningful and culturally appropriate way; and
- propose a procedure or a mechanism for receiving, registering and addressing grievances and suggestions from stakeholders.

The SEP is a "living" document and should be regularly reviewed, supplemented, and / or amended as the Project evolves. This SEP as well as its subsequent editions will be disclosed so that all the stakeholders can get familiar with this document.

# Restrictions influencing the Company's stakeholder engagement due to the COVID-19 pandemic

Restrictions related to the COVID-19 pandemic, primarily social distancing measures, may force not to use some approaches to stakeholder engagement and consultations. This may lead to the limitations of certain groups from the engagement process, for example, those who do not have access to the Internet or mobile communications. KazAvtoZhol NC JSC should consult with the Ministry of Healthcare of the RoK and its territorial divisions regarding the implementation of stakeholder engagement (in accordance with the requirements of national legislation and the EBRD). This SEP proposes some alternative methods for stakeholder engagement in the context of the COVID-19 pandemic, as recommended by EBRD (Section 2.2) and as stated in Table 4.

## 1. Project Description

The main objective of the Project is to improve the road infrastructure of the region, establish alternative transport connection between M32 and A17 highways, reduce the traveling time, reduce the transport costs and air emissions and ensure the road safety issues, including reduction of road accidents<sup>4</sup>.

The new Kyzylorda Bypass starts from the M32 (Samara/Uralsk-Shymkent) highway at point km 1827+472 through the two level transport junction and ends at the intersection of the bypass with the A17 (Kyzylorda-Zhezkazgan) road near the km 24+600. The total length of the road is 14.6 km, while the direct distance between the bypass starting and ending points is 12.8 km.

The engineering structures and transport interchanges/components of Kyzylorda Bypass Construction Project are listed below:

- 1) Passway of the local road with overpasses for grazing animals;
- 2) Bridge over the channel Kokjide;
- Two level interchange (connecting A17 highway with the Kyzylorda Bypass);
- 4) Two level interchange (connecting Kyzylorda Bypass with A17 road);
- 5) Rest area, consisting of three zones: parking for vehicles, rest area and sanitaryhygienic facility;
- 6) Storm water discharge system designed to install roadside trays along both sides of the bypass road and engineering structures;
- 7) Outdoor (street) lighting with a total length of lighting network of 38.54 km;
- 8) Concrete ditches for the Fiber-optic telecommunication line along the bypass roadside;
- 9) Road safety elements (road signs, guiding devices, roadside barriers, snow fences, road markings).

The map of the proposed Kyzylorda Bypass with the associated components and neighbouring facilities is presented in **Figure 1**.



To facilitate the Project implementation, it is envisioned to construct the technological earth road in parallel with the Kyzylorda Bypass (to be used during the construction stage) and to arrange a construction site consisted of a bitumen shop, asphalt plant and technical area (located close to the A17 Kyzylorda- Zhezkazgan road). The construction and auxiliary materials will be delivered by the railway up to the Belkol railway station and then by trucks to the Project area and construction site.

The projected traffic intensity along the Kyzylorda Bypass for the 20-year perspective reaches 9,231 vehicles per day for the target year of 2042. The duration of the Project construction stage is 22 months.

## 2. Legal Requirements Pertaining to Stakeholder Engagement

#### 2.1 National Requirements of Kazakhstan

The key legal acts related to the Environmental Impact Assessment (EIA) procedure and information disclosure, and applicable to the Project are described below.

The **Environmental Code**<sup>5</sup> of 2007 was the key environmental legal document of the RoK before the new **Environmental Code**<sup>6</sup> adopted in January 2021 entered into force on 1 July 2021, with some articles coming into effect stepwise.

A national EIA for the Project (including public consultations) was conducted according to the 2007 Environmental Code, with Article 57 of the corresponding Code stating that publicity of the State Environmental Appraisal (SEA) would be ensured through public hearings and that all interested citizens and public associations would be given the opportunity to express their opinion during the SEA. Articles 57-1 and 57-2 of the Code respectively described the means of public participation in the decision-making process on environmental protection issues and the projects for which it is mandatory to conduct public hearings. The latter also stated that "local executive bodies, twenty days prior to the holding of public hearings, provide open access to environmental information related to the EIA procedure of planned economic and other activities and the decision-making process for these activities through an Internet resource, as well as using other methods of information".

Since the 2021 Environmental Code provides for the public hearings during the national EIA procedure there are no requirements for accounting public opinion during the post-EIA stage, i.e. during the project construction or operation stages.

Article 8 **of the Instruction on the EIA**<sup>7</sup> elaborates on the accounting public attitudes in the development of the EIA. According to the Instruction, the project sponsor is responsible for organising and accounting public attitudes through public participation in the development and discussion of EIA materials.

The Rules on Access to the Environmental Information Related to the EIA (OVOS) Procedure and Decision-Making Process<sup>8</sup> determine the content and procedure for access to environmental information related to the procedure of EIA (OVOS) for all interested individuals and legal entities and their participation in the decision-making process on the planned economic and other activities. Interested parties/stakeholders can gain access to the materials of the SEA except for the confidential information (draft EIA; conclusions of external experts on the draft EIA; minutes of public hearings on the draft EIA; written requests from stakeholders on the draft EIA; the conclusion of the SEA) by sending a written request to the authorised body. The latter in accordance with the legislation within 15 calendar days gives a written response indicating the place and time where they can get acquainted with the requested materials.

The Instruction on conducting the Environmental Impact Assessment<sup>9</sup> defines disclosure process of Project information (environmental and social impacts, risks, etc.) through public hearings, gathering of written proposals and comments from the public as well as through gathering of written proposals and comments through a questionnaire survey of the Project area population. Pursuant the *Rules for conducting public hearings*<sup>10</sup> the public hearings are conducted through open meetings as well as through surveys.

When arranging an open meeting the project sponsor arranges with the respective local executive body the time and place of public hearings, a preliminary list of attended stakeholders and justifies

the optimum approach for notification (announcements in the media, newsletters, stands, written appeals).

The local executive body endorses the list of attended stakeholders, the notification method, the time and place of holding public hearings, and appoints the person responsible for holding public hearings.

When arranging public hearings through an enquiry the Project sponsor sent a notification to the respective local executive authority. The Project sponsor publishes an announcement in the media notifying about the public hearings. An official appointed by the respective local executive authority gathers the stakeholders' comments and recommendations and sends to the Project sponsor. Then the stakeholders' feedback is reviewed and a protocol of holding of public hearings through enquiry is made up.

The road construction projects are included in the list of economic operations, which design documents are subject of public hearings<sup>11</sup>.

#### 2.2 EBRD Requirements

EBRD has adopted a set of specific PRs that projects are expected to meet. One of them is EBRD's PR10: Information Disclosure and Stakeholder Engagement that recognises the importance of an open and transparent engagement between the client, its workers, local communities directly affected by the project and other stakeholders as an essential element of good international practice and corporate citizenship. Stakeholder engagement involves stakeholder identification and analysis, stakeholder engagement planning, disclosure of information, consultation and participation, grievance mechanism, and ongoing reporting to relevant stakeholders. Under PR10, EBRD requires that stakeholder engagement be an ongoing process.

The following elements of stakeholder engagement are applicable to the Project:

- Identification of project stakeholder groups. Identification of stakeholders, including members of the public who could be affected by the Project construction and operation activities:
- Stakeholder engagement process and information disclosure. During this stage, it is
  necessary to ensure that identified stakeholders are appropriately engaged on E&S
  issues that could potentially affect them through a process of information disclosure
  and meaningful consultation. Public disclosure of appropriate information is vital to
  enable meaningful consultation with stakeholders;
- Meaningful consultation and disclosure. The consultation process will be based on the
  disclosure of information relevant to the project activities and operations. The
  consultation process will be undertaken in a manner that is inclusive and culturally
  appropriate for all stakeholders;
- Grievance mechanism. Maintaining a grievance process by which the general public and other stakeholders can raise concerns, and which will be handled in a prompt and consistent manner.

In addition, the EBRD applies the Access to Information Policy (2019) that sets out how EBRD discloses information and consults with its stakeholders in order to provide sufficient information about the environmental and social risks and impacts arising from Projects and to engage with stakeholders in a meaningful, effective, inclusive and culturally appropriate manner consistent with the EBRD's E&S Policy.

In relation to the COVID-19 pandemic, the EBRD issued a briefing note to PR10<sup>12</sup> recommending the use of "alternative methods of disclosure and stakeholder engagement"; in particular: more informative content on project websites, the use of brochures, newsletter distribution via e-mail and messaging applications (e.g. WhatsApp, Telegram), sharing information and receiving feedback on social networks (e.g. Facebook, Instagram), sharing information through mass media, and posting announcements on local information stands. Recommended stakeholder engagement methods include telephone and online surveys and questionnaires, online engagement through social media, engagement through employees living in the locations of the Project sites, and through television and radio broadcasts. This SEP takes into account the EBRD's recommendations and proposes alternative engagement methods (Table 4).

## 3. Existing Stakeholder Engagement Practices and Previous Project Engagement

#### 3.1 Company's Existing Stakeholder Engagement Practice

The Company has an official website - <a href="https://ru.qaj.kz">https://ru.qaj.kz</a>, where visitors can find Call Center's telephone numbers, including a short number to be used from mobile phones; open line in the form of a chat is also available on the website, where operators can be asked questions online. A Situational Centre is developed on the website's platform where one can find an operative information on highway situations and incidents including highway hazard levels, traffic restrictions<sup>13</sup>. As part of the implementation of measures aimed at increasing transparency and openness, KazAvtoZhol NC JSC invites all active citizens, representatives of public associations and non-profit organisations to participate in the commissioning of the completed highway sections. To participate in the work of the commissioning committee, those who wish must fill out the questionnaire available on the Company's website<sup>14</sup>. Also, a Citizens' Reception Schedule by the management of the Company is posted on the website<sup>15</sup>.

#### 3.2 Stakeholder Engagement During the National EIA

The stakeholder engagement process within the national EIA was fulfilled in full compliance with the national EIA legislation (see Section 2.1). The engagement of public stakeholders at the early EIA stage when the stakeholders' attitude, concerns and recommendations towards the Project components were asked by the Project sponsor (KazAvtoZhol NC JSC) through the official requests sent to the following authorized public institutions:

- Veterinary Department of Syrdarya district,
- Department of Industrial and Innovative Development of the Kyzylorda region under the Akimat of Kyzyolrda region,
- Republican State Institution "Kazgidromet" under the Ministry of Ecology, Geology, Natural Resources.
- Communal State Institution for the protection of historical monuments and culture of Kyzylorda region,
- Republican State Institution "Aral-Syrdarya Basin Inspection for Regulation of the Use and Protection of Water Resources of the Committee for Water Resources under the Ministry of Ecology, Geology and Natural Resources,
- The Committee of Forestry and Wildlife under the Ministry of Ecology, Geology and Natural Resources.

Pursuant the national regulations (EIA instruction as well as Rules for conducting public hearings, see **Section 2.1**) public hearings were held in Kyzylorda city and Syrdarya District. Both public hearings were organized jointly by KazAvtoZhol NC JSC (the Project sponsor) and Department of Natural Resources and Environmental Management of the Kyzylorda Region (an authorized division of the local executive body). The reason to hold two public hearings was that the Project road crosses two administrative units of Kyzylorda Region. As stipulated by the national regulations the public hearings' announcements in Kazakh and Russian languages were published in the print media as well as were made available at the Kyzylorda Region Department of Natural Resources and Environmental Management's web-site. The EIA docs were made available at the Kyzylorda Environmental Department's web-site as well.

The summary of the public hearings is provided in **Table 1**.

## 4. Stakeholder Identification and Analysis

#### 4.1 Stakeholder Engagement Approach / Methodology

#### 4.4 Stakeholder Engagement Programme

The Stakeholder Engagement Programme (**Table 4**) is designed to ensure the most effective engagement with all identified stakeholders, to create and maintain respectful relations between the Company and stakeholders, and to prevent possible conflicts.

The Programme covers the design and construction stages and should be revised and updated at least within one year after beginning of the construction stage and then prior to commissioning the Project facilities. It provides a specific action plan with the distribution of responsibilities and a timeline for implementation of the suggested activities. If there would be changes during the Project implementation that require modification of the engagement mechanisms and / or new stakeholders are identified, the Programme should also be updated.

In case of adverse circumstances (epidemic or pandemic), all events requiring gatherings / major meetings should, if possible, be conducted online using alternative engagement methods (see **Section 2.2** and the Stakeholder Engagement Programme below).

#### 5. Grievance Mechanism

In order to enable the potentially affected or any other interested stakeholders to submit their grievances and/or suggestions about the Project's activities the Grievance Mechanism is set up by the Company. It is based on the existing Grievance Mechanism applied by KazAvtoZhol NC JSC and supplemented by additional measures in order to meet the EBRD requirements.

The Grievance Mechanism relies on the "Guidelines for grievance mechanism for environmental and social protection measures of the road sector projects" approved by the Committee for Roads (CoR) in 2014<sup>49</sup>. The Grievance Mechanism includes two levels of complaint management under the leadership of the CoR: Complaints Committee (CC) at the regional (Kyzylorda Region) and central levels (Nur-Sultan); and both CCs are chaired by managers responsible for the overall operation of the Grievance Mechanism and its effectiveness and timely implementation.

Grievances and proposals can be submitted to the Company in writing using the example of Prublic Grievance Form provided in **Annex 1**. Such forms will be published in Kazakh and Russian in electronic format on the Company's website and/or Project's webpage, and they will also be available in printed form near the boxes for grievances and appeals located in the Company's office, offices of the akimats, at the Project construction sites, etc.

Grievances received by phone, e-mail, mail, text messages (SMS), or messages in instant messengers or social media accounts will also be registered and considered. Grievances can also be submitted anonymously; however, it is recommended that contact details be provided so that the Company can provide a written response to the sender of the grievance.

According to the national legislation, appeal of an individual and (or) a legal entity, for the consideration of which it is not required to obtain information from other subjects, officials, or an on-site check, is considered within fifteen calendar days from the date of receipt<sup>50</sup>. The appeal of

an individual and (or) a legal entity, for the consideration of which it is required to obtain information from other subjects, officials, or an on-site check, is considered and a decision is made on it within thirty calendar days from the date of receipt by the subject, official. In cases where additional study or verification is required, the review period is extended by no more than thirty calendar days, which is communicated to the applicant within three calendar days from the date of the extension of the review period<sup>51</sup>.

All the grievances addressed to the Company will be recorded in a Grievance (and Proposals) Log, which should be maintained and analysed throughout the Project life-cycle.

#### 6. Monitoring, Evaluation and Reporting

Successful stakeholder engagement depends on continuous effort, performance monitoring and evaluation, and adapting to changed conditions and stakeholder information needs. In order to successfully organise, implement, evaluate, and report on the stakeholder engagement activities, central / regional CLOs will be responsible for these processes (the contact details are provided above). The following indicators will be used for monitoring and improving stakeholder engagement performance in support of the Project implementation:

- The SEP is developed, up to date, and available to the public for review/commenting;
- Actions listed in the SEP are completed in full and as scheduled;
- The topics that were discussed and the questions that were raised during the public consultations;
- Number of stakeholders' comments and suggestions received through various feedback channels;
- Number of stakeholders' grievances and claims received;
- Number of publications on the Project implementation process in local, regional, and national media;
- Key categories of grievances received by the Company or its contractors (employment, permanent or temporary land use, environmental issues, labour relations, etc.);
- Number of grievances resolved within the maximum established timeline;
- Number of grievances remaining unresolved.

The SEP should be periodically evaluated by KazAvtoZhol NC JSC in order to identify activities that might need any corrective and/or preventative measures with the purpose to improve the efficiency of its performance. In such cases the SEP should be updated and shared with the public with the amendments made.

The results of the stakeholder engagement process will be analysed monthly and quarterly, and a summary of the analysis will be included in the annual E&S reports submitted to the EBRD.
